Motion to table October 12, 2023, and October 17, 2023 minutes by Councilwoman Spires at **6:41 PM**, seconded by Councilman Jackson **(6:41 PM)**, Discussion: Councilman Drennan officially rescinds his vote from October 17, 2023, Council Meeting, he previously stated to rescind his vote during the November 9, 2023, Work Session in reference to the "Yea" vote for funds from Lexington County Recreation and Aging Commission to be allocated for the Town Park **(6:42 PM)**. Councilman Jackson states for the record: He also would like to rescind his vote alongside Councilman Drennan **(6:43 PM)**. Mayor Campbell informs the Council,

per Roberts Rules of Order, this must be stated at the very next meeting, which would have been the Work Session on November 9, 2023, as Councilman Drennan did. **No roll-call vote was taken**.

# IV. Departmental Reports - 6:44 PM

- <u>Chief Shumpert</u>: 173 citations written in October. December 1 the PD is hosting the "LEN" Law Enforcement Network checkpoint along with the Lexington County Sheriffs Department. This is once a year as part of the Eleventh Circuit of which we are a part of. All agencies in the surrounding areas, to include South Congaree, come together to address concerns and violations jointly, to include seatbelt violations, invalid Driver's License, and possession of drugs, whatever is found during the traffic checkpoint. Mayor Campbell asked Chief Shumpert, "Why would we tell people we are doing this?" Chief Shumpert and Captain Garner informed her they are required by law to publicly give the date. Mayor Campbell stated, "Thank you, we are not Law enforcement, but now we all know."
- Axon body cameras are up and running. Tasers are doing great, but the Police Department is still waiting for the car cameras with an estimated arrival time of three to four months.
- Officer Sharpe will be in training for the next few days. He is receiving his "SMD" Speed Measuring Device training and recertification.
- Chief Shumpert will be at the Chief's Conference from Thursday through Sunday. Major Jonas will be
  available for any issues on Thursday or Friday. (Councilman Drennan asked Chief Shumpert if the
  Police Department needed access to the new printers from their Patrol Cars. He is clarifying due to the
  quotes given for new printers.) Chief Shumpert clarified that this is not necessary because the cars are
  equipped with printers for tickets.
- Reserve Officers: Chief discussed reasons for the need for Reserve Officers. Reserve Officer Wilson was out with Sergeant Walker when an incident in town turned into a fight. The offender was not a small guy. This fight could have turned very bad because he tried to grab Sergeant Walker's gun. With the assistance of Reserve Officer Wilson, we were able to subdue the individual. Chief Shumpert continued to express his belief that Reserve Officers are highly needed as back-up Officers. Reserve Officers are not paid. They volunteer their time and dedication to the department and Town.
- Reserve Officer Gerald Crawford was sworn in by Chief Shumpert (6:50PM) upon successful
  completion of the Reserve academy accredited by the South Carolina Criminal Justice Academy. Chief
  Shumpert discussed Mr. Crawford's accomplishments and recognized his family during the swear-in
  process.
- Reserve Officer Kevin Miller was sworn in by Chief Shumpert (6:52PM) upon successful completion of the Reserve academy accredited by the South Carolina Criminal Justice Academy. Chief Shumpert discussed Mr. Miller's accomplishments and recognized his family during the swear-in process.
- Chief Shumpert discussed new uniforms. He is looking to changing to the new water repellant uniforms. Councilwoman Spires addressed the cost and necessity for evaluating for budget purposes.

## Captain Garner Report 6:57 PM

- Captain Garder discussed Wal-Mart Grant for Stop-sticks being in the final stages. This is a no match Grant.

## IX. Citizen Comments 7:20 PM:

- 7:20 PM Debbie McIver: Good evening, Council and Town Citizens, as part of the committee for the annual tree lighting ceremony and the parade, I would like to make a quick announcement. Sunday, December 3<sup>rd</sup>, at 5:00PM at the Christmas tree on 302 and Ramblin. We will have our annual Christmas Tree Lighting Ceremony. There will be food trucks and a sip truck to include coffee, hot chocolate, and other beverages. These are for purchase. There will be speakers and entertainment to include Congaree Elementary School Choir. Santa will be making a special appearance. The parade will be on Saturday, December 9th at 10AM. Everyone is invited to come out and enjoy the Christmas Parade this year. There will be a special Grand Marshall, it is going to be "Cocky". (Unspoken: "Cocky" is the costumed mascot of the University of South Carolina). Parade entries are still being accepted. This is great free advertising and a way to support your community. It is going to be a great community day. We are looking for this to be the biggest we have had yet in the history of South Congaree. Any questions? Question/Discussion 7:22PM: Councilman Drennan requested to make a motion that the Town of South Congaree accept liability for that property. That is the requirement Lexington Medical has put on us whenever we sign off that we have liability for it. I think we should have a motion to vote. Councilwoman Spires interjected, "We are covered for this." Councilman Drennan reiterated we are, but we have not voted to have it there. Ms. McIver stated we have always had it there, haven't we? We have per Councilman Drennan, but you have to sign a contract, and all contracts are normally by council. Mayor Campbell, in speaking with the council stated, "she has never signed a contract", and refers to the Town Attorney John Rakowsky for guidance. Mr. Rakowsky responded, "No, we have insurance." Councilman Drennan continued to seek clarification as to liabilities and if a contract is needed. The Christmas Committee nor the Council had previously signed a contract. Per the Town Attorney, "The Town is covered for these events under their liability insurance, and creating a contract would be a duplication of liability acceptance." Councilman Drennan questioned, "So any of us could use this property?" Mr. Rakowsky clarified that the Town could use these and would be covered, not individuals." This is the Town's Christmas Tree Lighting, per Mayor Campbell. Discussion referring to how the town had used this property for numerous years continues. Clarification is rendered to establish a difference between an Individual requesting to use said property versus the Town of South Congaree.
- 7:25 PM Marty Wooten: I live in front of Columbia Auto Parts. Mr. Wooten is requesting a Junkyard/Scrapyard Ordinance for South Congaree. It's been going on since last July, with tires and now American Scrap has got a business license for towing, but here comes a rollback load of waste oil coming in. Their trash bin truck is bringing in tires, rims, so, I mean what are y'all dong? If it was over in front of Drennan's house we'd be taken care of. If it was over in front of any of y'alls houses, we would be taken care of. So, what are we doing by the Council to help this? We don't see any police up there. We don't see them going up and down the road. I mean, it's just simple, where's that liability? You want to sign a contract? Let's get one. I mean y'all need to do something. Y'all take an oath, do

- you serve the citizens or the businesses? What is in that Oath? I just heard it from the Police, I didn't hear business. I heard citizens. I send emails. Do y'all get my emails? Council responds "Yes." Mr. Wooten replied, "I don't get any responses." <u>Responses have been made by all Council to include the Town clerk is clarified. It is stated a special called meeting will be called to discuss this matter.</u>
- Mr. Wooten continued to discuss Tim Dickensheets, the property owner, and S. Horton Properties' sale not a lease. Councilman Jackson questioned if the gates have been reopened, or is it being used for storage do you think? Mr. Wooten replied, "I don't know what they are doing." Last he heard was from Sergeant Walker, and that they rode by to check for activity. Per Mr. Wooten, "We don't know what that activity is supposed to be. They are in and out. I could probably give you a count of the cars towed in and out in the last month." Mayor Pro-Tem Mabry replied to Mr. Wooten, "We have discussed it, and you and I have discussed this." Every one of us has discussed this. Mr. Wooten continued to seek out where an Ordinance is. Mayor Campbell stated, "We as a Council have not discussed this." Mayor Pro-Tem Mabry clarified we asked for attorney advice on some things. The Council had an Executive Session in reference to this issue but have not met to discuss it since. Mr. Wooten stated, "The town is dragging their feet and kicking the can down the road, just like was done with the printer. If you get Mr. (Captain) Garner over here to do your printer, you will probably have it in a day, because he does a good job at what he does." Mayor Pro-Tem asked who just got their business license? American Scrap per Mr. Wooten.
- Mr. Wooten continued, "T & S Real Estate does not have a business license and that is who owns the property. Y'all do some research. I am just a common citizen." Mayor Campbell addressed Captain Garner, "Do you have any experience or have anything you would like to add in regard to this?" Captain Garner addressed the Council stating that he would sit down with Sergeant Walker to discuss, then set up a meeting. Mayor Campbell requested to include the Wootens in the meeting. Councilwoman Spires requested that Captain Garner inform the Council as to the outcome of that meeting. Councilwoman Spires asked Mr. Rakowsky (Town Attorney) to please work with them, he states, "I have been." Councilwoman Spires asked Mr. Rakowsky, "Why don't we have a solution?" Mr. Rakowsky replied, "The last meeting I had, I thought it came out good, so I feel like I am blindsided by the complaint because we had a meeting specifically with Columbia Auto Parts and their lawyer to address these concerns. They were advised to get a certain business license to operate." Councilwoman Spires stated she was unaware of this meeting and the results. Captain Garner responded, "Rather than labor the point, let's just get a game plan and go from there." Clarification: all of the Council has responded and the Town clerk. It is stated a "special called" meeting will be called to discuss this matter.
- "The council needs to adopt an Ordinance to protect the citizens," stated Mr. Wooten. Discussion in reference to the procedures for an ordinance continued. Mayor Pro-Tem Mabry stated DHEC has been called in, Mr. Wooten replied, yes, and that's our solution there, but there's ordinances that need to be in place. Lexington County has them. Mayor Campbell stated, so what I am hearing from you is, you want the Council to work on an Ordinance that protects the citizens in that area? Mr. Wooten replied, yes. Mayor responded, "we can do that."
