I. Call to Order

Mayor Campbell called the meeting to order at 6:00 PM. A quorum was present. Mayor Campbell led in the Pledge of Allegiance and Invocation.

Mayor Pro Tem Spires made a motion to move item c. from New Business into executive session. Council Member Jackson seconded the motion.

c. Discussion of Council Priorities Pertaining to Palmetto Land Use Planning, LLC. Zoning Consultant Scope of Work (Pursuant to S.C. Code Ann. § 30-4-70 (A) (2))

The motion passed unanimously.

II. Adjourn to Executive Session

Mayor Campbell made a motion to enter executive session for Discussion of Personnel Matters Related to the Police Department (Pursuant to S.C. Code Ann. § 30-4-70 (A) (1)), to Receive Legal Advice Concerning Amending Town Ordinance Pertaining to Special Events Permit (Pursuant to S.C. Code Ann. § 30-4-70 (A) (2)), and for Discussion of Council Priorities Pertaining to Palmetto Land Use Planning, LLC. Zoning Consultant Scope of Work (Pursuant to S.C. Code Ann. § 30-4-70 (A) (2)). Council Member Jackson seconded the motion. Council entered Executive Session at 6:03 PM.

The motion passed unanimously.
